1. Introduction

Brief Introduction to Organization:

Freedom Forum is an independent, non-governmental and not-for-profit civil society organization working for democracy and human rights focused on press freedom, freedom of expression, right to information and governance in Nepal. Incepted in 2005, FF has emerged as a prominent national organization in promoting access to information, freedom of expression and open development. The organization is also working on the issues of open governance/open data, public finance management, budget/aid transparency and political and parliamentary accountability and electoral reform. Adding new dimension to its regular activities, FF initiated Gender monitoring of Nepali media contents since last year.

This is a purely social organization registered with the District Administration Office of Kathmandu (Regd.127/062/063) and the Social Welfare Council (Affiliation No.18518) of Nepal. Its head office is in Kathmandu, Nepal. FF has different contact offices and representatives in provinces and district sites. It has 11 member Board of Directors, 52 general members, and 17 staffs. Annual General Meeting is the apex body of the organization and it takes place every year.



Our activities are focused on promoting democratic principles, norms, values and




standards and strengthening democratic structures and institutions to foster democratic culture in Nepal. Activities carried out during this year under this theme are as follows: and major activities undertaken by FF

A. Discussion on 'Open Parliament: Concept and Practices' in seven provinces:

In a bid to promote open parliament initiatives at province and federal levels, seven events were held in the capital cities of all seven provinces with support

from Parliament Support Programme/ UNDP.

The programs were attended by parliamentary committee presidents, lawmakers, media persons, government officials, university teachers, legal practitioners,

B. Federal dialogue on 'Open Parliament, Open Government: Concepts and



Out of 42 participants, there were 10 females in the discussion event. The main objective of the discussion was to prioritize the idea of government openness on response and recovery in regards to the time of pandemic and COVID-19 crisis.

II. Freedom of Expression:



Among the major accomplishments made by FF for the consolidation and strengthening of freedom of expression and of press are constant lobby and advocacy for policy reform on media sector, public awareness,

drawing up Agenda for Change (AFC) as a long-term plan for the enhancement of freedom of expression in line with international standard. Specific activities carried out under this theme are:-

A. <u>Training to advocate on FoE and Media law:</u> In the wake of growing press freedom violations and increase in the cyber crime endangering freedom of expression online,

FF organized 3-day training cum workshop. During the program held in Budhanilkantha, Kathmandu from 16 to 18 August, 20 advocates including 7 femalestwo each from seven provinces and 6 from the Kathmandu Valley— took part to learn the



national and international provisions and standards on Freedom of Expression (FoE), privacy, cybercrime, journalist safety and impunity for crime against journalists.

B. <u>Multi-stakeholder dialogue on FoE, media law</u>: FF organized a multi-stakeholder discussion in Kathmandu on July 30. The program was organized in the presence of members of the Federal Parliament, members of Province-3 Assembly, university teachers, researchers, media persons, FoE practitioners and rights defenders. The program, held as part of the program "Civil Society Mutual Accountability Project (CS:_MAP)" with the support of FHI360, was attended by 55 participants. Out of 55 participants, there were 17 female and there were total 18 lawmakers from Federal and Provincial Parliaments.

C. End Impunity Day marked nationwide in Nepal:

The International Day to End Impunity for Crimes against Journalists' was marked



across the nation in November. It is observed in a bid to raise awareness on journalists' rights, express solidarity to the campaign of journalists' safety and advocate for justice to the victim journalists and media persons in order to end impunity for the crimes meted out against them. Three awards were also conferred to three candidates under Courageous Journalism, Best RTI Activist and Investigative Journalism categories.


E. <u>Dialogue on 'Art, Creation and</u>

Freedom Forum has managed insurance worth Rs. 100 thousand to each journalist affiliated to the Online Journalists' Association. Shikhar Insurance arranged the facility for it.

III. Right to Information and Open data:-

FF organized various campaigns, trainings and discussion programs under this theme during this year.

A. RTI Nepal App: FF is running RTI Nepal android mobile App which is an integrated package on several practice-, is aimed aware on use of RTI and governance endeavor in

dimensions of RTI- from principles to making public and the media persons its benefit for contributing to the good the country.

B. Celebration of International Right to Know Day: Freedom Forum (FF) has continued its endeavor for the cause of good governance by making public agencies transparent and accountable and sensitizing citizens from across the country on importance of information with the use of Right to Information (RTI) applications. F. <u>Open Data Training in Gaindakot and Kathmandu</u>: The training was provided to total 28 youths (12 in Kathmandu and 16 in Gaindakot). The training was conducted



in the framework of prior assessment, do, learn, review and apply. Assessment of prior knowledge of the participants was done by placing questions around social security allowance such

as – do anyone in their family members receive social security allowance? If yes what type? How much government allocation on social security? How do they know this? Main aim of the session was to enable local CSOs to define the benefits of open data and use open data and RTI in monitoring social security allowance.

IV. Gender Justice in Media:

FF continues monitoring Nepali media contents through gender perspectives. This year monitoring was conducted at central and provincial level, monitoring nine national dailies and six online news portals in central and 21 major provincial dailies from seven provinces.



Specific activities carried out are as follows:

A. Reports on Gender Content Monitoring Published: The report of monitoring throughout a year is published on quarterly basis. The first report of the year was published from July to September, 2nd, 3rd and 4th from October to December, January to March and April to June respectively.

The report is prepared after analyzing the data recorded from main news contents and op- eds of all selected media outlets.

B. March 8: Advocacy for more Women in Media for Inclusive Media: FF marked the International Women's Day showing solidarity through social media platforms and doing photo session holding placards which read: *change the stereotype, change the image, stand up for the women in the media, protect women's right.* Campaign was



organized for sensitization of women rights and advocacy of equal rights of women in media.

C. Interface 'Women's Presence in Nepali Media': Two interfaces were organized where participants were from media fraternity. The interfaces were organized as part of the project named CACFRIIM; one was held at the capital city and another in Bardibas, a city in southern plains. At the programs, journalists from different media houses talked about women not getting unequal opportunity and pay gap among women and men and also media houses' trust upon women journalists on reporting important issues.

V. Media Policy Reviews/ Program:

FF also reviews national policies through FoE perspectives with its background on advocacy on issues of freedom of expression and information. This year FF reviewed and disseminated the papers on various policies brought forth in Nepal under the project EEMIR- CS: MAP.

A. <u>Multi stakeholder discussion on "Media Council Bill"</u>: National Assembly members agreed to reform regressive provisions on media council bill after taking suggestions from stakeholders and reiterating the preparation and process of reform



as per the demand of the concerned. The commitment of policy makers came during the organized on 25th August 2019 by Freedom Forum in Kathmandu. Various

National Assembly members, Editors, former representatives of Press Council, lawyers and other concerned media stakeholders participated in the policy dialogue event on the proposed bill, which has been already registered in parliament (NA) now.

Review of Public Service Broadcast Bill: The government registered long- awaited bill in the parliament on July 29 to amend and consolidate the laws on public broadcasting to change the existing regulation system of Radio Nepal and Nepal Television. Following this, FF made various comments and recommendations to be



amended on the provisions included in the bill to make it globally recognized as per the characteristics and global experience of a public service broadcaster. The review report is soon to be published.

E. Review of Gandaki Province's Mass Communication Policy: FF submitted

27 points recommendations by reviewing the Mass Communication Policy of Gandaki province to the parliamentarians of Gandaki Province assembly. FF has dragged attention towards provisions which are detrimental to the functioning of journalism effectively and efficiently. FF also found that excessive authority is given to levy hefty punishments to some authorities which can easily be misused and are against the notion of the principle of natural justice, which discourages the journalism in the modern digital era.

F. Review and submission of Nepal Special Service Bill: FF made the review of the Nepal Special Service Bill introduced in the parliament-secretariat by Prime Minister and Cabinet's Office on 30th Dec 2019. The study and review of the bill revealed that the provision of 'interception' was damaging to free reporting. It would foment self-censorship among journalists; pose a serious risk to source protection and kills investigative reporting. Therefore, FF strongly recommended the federal parliament to amend the concerned provisions. FF submitted the proposed amendments and

policy briefs on the Act to influential lawmakers in both the upper and lower houses of the federal parliament.

G. <u>Discussion on Media Bills of Province-2 and Stakeholder Concerns</u>: A virtual discussion was organized on July 14 where representatives of FNJ Chapter of Province-2, media persons including others showed their concern, saying it was passed by the Province Assembly without hearing the demand and protest against the provisions in the bills. The major objective of the event was to seek common understanding regarding conflicting provisions of the bills and press the government and the Province Assembly to amend those regressive provisions sooner.

B. Inception workshop: FF organized inception workshop



as an initiation of the project. With a view to promoting audit accountability, Freedom Forum (FF) on November 22 organized an inception workshop of Audit Accountability Initiative project in collaboration with the Office of the Auditor General of Nepal and International Budget Partnership (IBP).

A total of 43 personals were present in the meet including 3 from Office of Auditor General Nepal, representatives from PPMO, Nepal, members of Legislative assembly, other government personals, CSOs and Media personals.

C. Meeting with CSO representatives: FF with support from IBP organized a CSOs meeting at Kathmandu on December 9, 2019 in Kathmandu. The meetings was held with an aim to introduce IBP to other CSOs in Nepal, to share the participants and their work, to share the goals and framework of IBP's new initiative, to reflect on the political context for fiscal accountability and participation in Nepal, to answer participants questions and to get CSOs feedbacks and suggestions for the initiative going forward. A total of 15 participants were present in the meet including 2 representatives from IBP.



D. Meeting with representatives from Office of Auditor General:

FF organized a meet with representatives from Office of Auditor General for discussion in relation to the audit recommendations follow-ups and updates on the same. The

event was held on February 18, 2020 in Kathmandu. The meet focused on the present

status of audit follow up norms of the Office of Auditor General, international standards, and progress last report recommendations on current climate of works. Both FF and representatives of OAG agreed on need for just not only the act of follow on recommendations execution but there is essential need on policy and regulation changes for effective follow



within the policy of Office of Auditor General and Government. A total of 10 participants were present on the meet including 5 form office of Auditor General and 5 from Freedom Forum.

VII. Open Budget Survey in Nepal:

The Open Budget Survey (OBS) is the world's only independent, comparative and fact-

based research instrument that uses internationally accepted criteria to assess public access to central government budget information; formal opportunities for the public to participate in the national budget process; and the role of budget oversight institutions such as the legislature and auditor in the budget process.

A. <u>Circulation of Open Budget Nepal Survey report:</u> With the view of drawing government attention to this report and its recommendations which would be useful for the government to initiate reforms in budget processes and policies; at a time when the executive is presenting the federal budget in the parliament on May 28 (14 Jestha), we circulated the Open Budget Nepal Survey 2019 (both Nepali & English Edition) to following Government Personals, Appointees and Elected Officials.

B. <u>Open Budget Survey report dissemination</u>: A dissemination program was organized on May 20, 2020 among 15 economic journalists through Zoom online platform in presence of Society of Economic Journalists' Nepal (SEJON)'s president Bhim Gautam.

VIII. Legal Aid to journalists:

Our regular FoE monitoring has revealed that many journalists have been attacked, threatened and misbehaved for doing their job. Few are also arrested and have faced legal prosecution for practicing their rights. With this backdrop, FF initiated legal aid program for journalists in support with Free Press Unlimited under Legal defense fund



project. A legal help desk established at FF has a legal officer who identified, studied the cases and decided to provide legal assistance to the journalist.

Journalists receiving aid are:

1. Journalists Tanka Bahadur Sunar and Bimal Bhattarai associated with www.darpanpost.com were falsely accused of committing defamation by publishing

news through their online news portal. The chairperson of Haldi Bari Rural Municipality of Jhapa district Rabindra Prasad Lingdel filed a case against the defendant on 21

April, 2019. FF helped
Sunar with transportation
and accommodation
expenses. FF had
appointed a senior
advocate for legal
representation in the court.
All the legal fees and costs
were also covered.



After several rounds of proceeding, the Jhapa District Court announced his innocence by dismissing the case altogether.

2. *Journalist Gaurav Khanal* from Butwal was charged with the Cyber Crime case under Electronic Transaction Act, 2006. FF helped journo Khanal- paid the initial deposit of



Rs. 20,000 for his release and hired an advocate who represented him in the court. As journo Khanal had to be present in front of court in every hearing date, FF helped him with the travel expenses as well.

Finally Kathmandu District Court gave

its decision in favor of journalist Gaurav Khanal on September 24. Journalist Khanal, who was accused of cyber crime, was acquitted in the case.

3. Journalist Om Hamal was arrested by the security officials for himself being allegedly associated with Biplab-led Maoist group and later case of state offense was filed against him for supporting the faith of a party, banned by the government. During the legal battle FF helped journalist and his wife in terms of legal and financial support. Even FF's appointed a senior advocate who represented journalist Hamal at Supreme Court hearing.

Later, on September 10, SC once again ordered government to release journalist Hamal ensuring justice to him and his profession.

- 4. Journalist and Youtuber Santosh Deuja associated with an online news portal www.kapurbot.com has been sued under cyber crime following a defamation complaint lodged by Local Neelam Shah. He is charged under Section 47(1) of Electronic Transaction Act 2063. Since the beginning of the case, FF has been continuously providing legal as well as financial support until this period. FF will provide him financial aid in transportation and accommodation related expenses for him to be able to commute from Simara to Kathmandu. Accordingly, FF will support in final case hearings by legal representation, preparing pleading notes, giving legal advises as deemed required.
- 5. Three journalists (Sunita Rawal, Prakash Bam and Chakra Kunwar) associated with Radio Nepal Far Western Broadcasting Office were discontinued from service without formal notice. The journalists were denied of their service contract without providing any kind of explanation and opportunity to defend. FF has helped to successfully register the case in the Labour Court and is providing necessary legal advices to the journalists to help them avail rightful legal remedy. FF has also appointed lawyers to help them in the legal proceedings. Since, the Labour Court is based in Kathmandu, FF has been providing them transportation and accommodation assistance to make their travel possible from Doti District.
- 6. Freelance journalist Ek Raj Silwal based in Kathmandu was denied pubic information



about a bidding procedure of the construction of the school. After the school denied giving the information, Silwal filed the case regarding breach of right to information in the National Information Commission (NIC). The NIC then, announced the judgement on Silwal's favour and levied monetary penalty and asked the school to levy disciplinary punishment to the information officer.

The defendant filed an appeal in the High Court which did not obligate the defendants to give the information to Silwal and also lowered the

amount of monetary penalty. Now, the case is filed for review in Supreme Court to reaffirm the judgment of NIC. After the preliminary hearing, the court has given affirmative response to go ahead with the future proceeding.

FF has been assisting Silwal with the legal support at the Supreme Court till date.

4. Publications:

Besides several programs implemented in partnership with funding agencies, FF's published several policy reviews, reports, books and drafts this year.

A. <u>Newsletters- Free Expression:</u> FF published total four issues of newsletters during this year. All the issues highlighted the activities carried out by the organization. It mainly covers media monitoring reports, policy/impunity watch, RTI campaigns and other collaborative approaches. Those issues are also uploaded on its website and made public. Each issue of newsletter contains three monthly proactive disclosure section of FF's delivdrables.
